INTRODUCTION

Baccarat, Inc. ("Baccarat", we, or us) operates www.Baccarat.com(this "Website"). We recognize that you care how information about you is used and shared. We have created this privacy policy ("Privacy Policy") to inform you of our information collection, use and sharing practices for this Web Site. This Privacy Policy only covers information collected at this Web Site, and does not cover any information collected offline by us.

Security

Baccarat will take measures to protect your personal data in its possession or under its control by making reasonable security arrangements to prevent unauthorized access, collection, use, disclosure, copying, modification, disposal or similar risks. When we no longer need to use your information, we will take steps to properly de-identify or destroy it. Personal information provided on the Web Site are transmitted through a secure server using Secure Socket Layering (SSL), encryption technology. When the letters "http" in the URL change to "https", the "s" indicates you are in a secure area employing SSL; also, your browser may give you a pop-up message that you're about to enter a secure area. We are committed to handling your personal information with high standards of information security. We take appropriate physical, electronic

and administrative steps to maintain the security and accuracy of personally identifiable information we collect, including limiting the number of people who have physical access to our database servers, as well as employing electronic security systems and password protections that guard against unauthorized access. This website uses encryption technology, such as Secure Sockets Layer (SSL), to protect your personal information during data transport. SSL encrypts ordering information such as your name, address, email address, phone number and stores also operate over a private, secure network.

It is the state of affairs, however, no data transmission over the internet can be guaranteed secure. As a result, while we strive to protect your personal data, we cannot guarantee the security of any information you transmit to us through this Website and you use this Website at your own risk.

If you do not provide Baccarat with all requested personal data, we may be unable to assist you

Where practicable, we will collect personal data directly from you.

How we use the information we collect

We use the information we collect for various purposes, including:

to provide the desired goods and the services you request

• to respond to your queries if you are seeking information about our products or services;

• to communicate with you about our products and services;

• to conduct promotions, competitions and sweepstakes;

- to conduct market research and analysis;
- to process and assess employment applications;
- to enforce agreements between you and us;
- to send you our catalogs and other offerings by mail or email;
- to administer our membership list, if any;
- to identify your product and service preferences, so we can notify you of new or additional activities, services, and promotions that might be of interest to you;
- to tailor ads on our website, social media platforms and elsewhere to your interests and history with us;
- to comply with legislative and regulatory requirements;
- to operate our business efficiently;
- to create, develop, operate and deliver our products and services;
- to improve our merchandise selections, customer service, overall shopping experience,
 site design, product assortments and special promotions;
- to detect and prevent frauds; and
- to avoid duplication and ensure accuracy of your Information, periodically conduct data cleansing, linking or merging of our records, either internally or through our service providers.

Baccarat may also use and process aggregated, anonymous data about its customers and website users as a group, for Baccarat's business purposes.

Others with whom we share your information:

- Affiliates of Baccarat: All of the above information that we collect, as described above,
 may be shared among all Baccarat entities.
- bring you the products and services we offer.
